• Oral Health/Laura McKeane:

- Laura mentioned that she felt the workgroup report template felt intimidating- the Curry CHIP Communications team will work to simplify the report template- Laura reviewed her Oral Health report listing the community partners involved and she referenced the 2018 oral health CHA data that's driving their work to provided dental services in the underserved areas of Curry, focusing now on Port Orford
- Laura referenced their workgroup's goals to work on integration and get oral health services started in Port Orford provided by Advantage Dental in partnership with Coast Community Health. They will also offer a voucher program (for those not on OHP)
- Long term indicators- increase preventative measures

Workgroup Updates

- Housing & Homelessness/Beth Barker-Hidalgo:
- Beth reported via email that the Curry Homeless Coalition delivered dry bags, sewing kits, toe
 warmers, hand sanitizer, & hard surface sanitizer spray to the Brookings Homeless Task Force this
 week and also ordered tarps for BHCH, for pick-up at FM.

- Access to Health/Connie Hunter:
 - o Not present but Connie sends regular email updates to community partners
- Food & Nutrition/Pamela Winebarger:
 - Short term targets: snack pack program still underway
 - Last of "plant a row" 1800 lbs of grown food received lasat year for families in need
 - Free produce program coming to Curry
 - Can recycling fundraiser in the works- see details below in the community updates section

• Youth & Seniors/Bonnie Ell:

- High-level strategies:
 - Support efforts to mitigate trauma, increase supports that address the socialemotional health of our youth & seniors, support collaborative efforts
 - Strengthening family preservation & the protective factors that influence that (ACEs, overall supports, etc)
 - Coordination of services and systems
- E.g. CHA data shows that Curry County ranks low for foster placement relates closely with Every Child Curry who is working on:

- **Behavioral Health & Addictions/**Nancy Tourney:
 - Focused on increasing suicide awareness
 - Staff trained to provide Question Persuade Refer (QPR) training in BH school district, will reach out to other school districts and community
 - Stigma/myth busting last year, hoping to do this virtually this year
 - o Prevention/awareness brochures available in 100 locations
 - Oregon ranks 4th in suicide-related crisis texts, most crisis texts received 10pm-2am, 72% of texters are youth – see http://www.zeroattempts.org/charts/ctl-issues.html for additional data
